To assist with answering questions appropriately, CPMB requests attendees include the abbreviated initials of your agency's program in addition to your Zoom display name. For example: Jane Doe – CR or John Doe – ASC. You may edit your Zoom display name prior to entering the webinar or edit your name after you have joined.

Add the following abbreviations to your name to reflect your program:

ASC - Adult and Senior Care Program CC - Child Care Program CR – Children's Residential TLR – TrustLine HCS – Home Care Services

How to edit your Zoom display name:

- 1. After joining the meeting, select the "Participants" button at the bottom of the Zoom meeting window.
- 2. A list of participants in the meeting should appear on the right side of the window. Use your mouse to hover over the three dots near your name, then select **Rename**.
- 3. A text box will appear containing your current name. Delete it and enter your new display name, including the appropriate program type outlined above.
- 4. Select **Change** to save the edits.
