Medicare-Medicaid Plans

Attached to this memorandum is the final Contract Year (CY) 2023 Marketing Guidance for Medicare-Medicaid Plans (MMPs) operating in the South Carolina capitated financial alignment model demonstration. CMS and South Carolina jointly updated the Marketing Guidance for South Carolina MMPs, in accordance with provisions of the Three-Way Contract.

All Medicare Advantage-Prescription Drug (MA-PD) plan sponsor requirements in 42 CFR Parts 422 and 423 as well as all MA-PD plan sponsor requirements in the Medicare Communications and Marketing Guidelines (MCMG), posted at www.cms.gov/Medicare/Health-Plans/ManagedCareMarketing/FinalPartCMarketingGuidelines apply to MMPs participating in the South Carolina capitated financial alignment model demonstration, except as clarified or modified in this Marketing Guidance. In addition, the Centers for Medicare and Medicaid Services (CMS) recently codified guidance on May 9, 2022, which also applies to MMPs except as clarified in the Marketing Guidance. The Marketing Guidance is applicable to all South Carolina MMP marketing for CY 2023 benefits.
