## **66250.1 Disclosure Categories**

Designated positions in this category must disclose, pursuant to instructions and forms prescribed by the Fair Political Practices Commission, the following:

## (a)

All investments and sources of income, including gifts, loans and travel payments, from business or nonprofit entities that do business or receive income from any source within the State of California.

#### (b)

All interests in real property in California.

#### (c)

Any positions held in business entities that do business or receive income from any source within the State of California.

Designated positions in this category must disclose, pursuant to instructions and forms prescribed by the Fair Political Practices Commission, the following:

#### (a)

All investments in business entities whose activities are subject to regulation or oversight by the Department or that contract, or are the type that contract, with the Department to provide services, supplies, materials, machinery or equipment.

#### (b)

All interests in real property in California.

#### (c)

Any positions held in business entities whose activities are subject to regulation or oversight by the Department or that contract, or are of the type that contract, with the Department to provide services, supplies, materials, machinery or equipment and income, including gifts, loans, and travel payments, from those sources.

#### (d)

All sources of income, including gifts, loans and travel payments, from business or nonprofit entities whose activities are subject to regulation or oversight by the Department or that contract, or are of the type that contract, with the Department to provide services, supplies, materials, machinery or equipment.

#### (e)

All investments and business positions in business entities and sources of income (including receipt of gifts, loans, and travel payments) if the business entity or source is, or was, during the current legislative session, registered as a "lobbyist," "lobbying firm," or "lobbyist employer."

Designated positions in this category must disclose, pursuant to instructions and forms prescribed by the Fair Political Practices Commission, the following:

#### (a)

Any positions held in business entities that contract, or are of the type that contract, with the Department to provide services, supplies, materials, machinery or equipment.

## (b)

Any sources of income, including gifts, loans and travel payments, and investment

in business entities that contract, or are of the type that contract, with the Department to provide services, supplies, materials, machinery or equipment.

Designated positions in this category must disclose, pursuant to instructions and forms prescribed by the Fair Political Practices Commission, the following:

## (a)

All investments and sources of income, including gifts, loans and travel payments, from business entities that provide information technology (IT) or telecommunications goods, products or services including computer hardware or software companies, computer consultant services, IT training companies, data processing firms and media services.

## (b)

Any positions held in business entities that provide IT or telecommunications goods, products or services including computer hardware or software companies, computer consultant services, IT training companies, data processing firms and media services.

Designated positions in this category must disclose, pursuant to instructions and forms prescribed by the Fair Political Practices Commission, the following:

#### (a)

All investments and sources of income, including gifts, loans and travel payments, from business entities that provide leased facilities, products, equipment, vehicles, machinery or services, including training or consulting services, of the type utilized by the Department.

## (b)

Any positions held in business entities that provide leased facilities, products,

equipment, vehicles, machinery or services, including training or consulting services, of the type utilized by the Department.
