Provider Information Notice (PIN) Summary

PIN 22-1-ASC announces the release of the Infection Control Plan courtesy forms for Adult and Senior Care (ASC) facilities with the exception of Adult Residential Facilities for Persons with Special Health Care Needs (ARFPSHNs). These courtesy forms include a section for the Infection Control Plan and the Emergency Infection Control Plan.

Please post/keep this PIN in the facility where persons in care can easily access it.

To help licensees meet the Infection Control Requirements regulations, the Community Care Licensing Division (CCLD) has created two Infection Control Plan forms, the <u>Adult Day</u> <u>Program Infection Control Plan (LIC 9283)</u> and the <u>Residential Infection Control Plan form (LIC 9282)</u>. The Residential Infection Control Plan can be used for Adult Residential Facilities (ARF), Community Crisis Homes (CCH), Enhanced Behavioral Support Homes (EBSH), Residential Care Facilities for the Chronically III (RCFCI), Residential Care Facilities for the Elderly (RCFE), and Social Rehabilitation Facilities (SRF). The residential form does not apply to ARFPSHNs because the Infection Control Requirements did not apply to ARFPSHNs.

These forms provide a comprehensive template for use in developing an Infection Control Plan and an Emergency Infection Control Plan. The forms are provided as a courtesy to help PIN 22-18-ASC Page Two

applicants and licensees meet the requirements pursuant to the applicable Infection Control Requirements section of the California Code of Regulations (CCR), Title 22: <u>Section 82095.5</u> for Adult Day Programs (ADPs); <u>Section 85095.5</u> for ARFs, CCHs and EBSHs; <u>Section 87895.5</u> for RCFCIs <u>Section 87470</u> for RCFEs; and <u>Section 81095.5</u> for SRFs.
